19 Mayor Kolupski called the meeting to order at 7:00 p.m. and led the audience in the United States
20 and Texas Pledge of Allegiance.

22 **1. PRESENTATIONS**

24 **1.1** Presentation to recognize McDonald's of Seabrook as the Seabrook Economic Development
25 Corporation's Business of the Year for 2019. *Paul Chavez, Director of Economic*
26 *Development*
27

28 The Seabrook Economic Development Corporation has chosen McDonald's of Seabrook
29 as the 2019 Business of the Year.
30

31 Mayor Kolupski presented the franchise owner, Robert Flores, and his daughter, Carrie,
32 along with McDonald's of Seabrook Manager, Jennifer, with the plaque on behalf of the Seabrook
33 EDC and City Council. Mayor Kolupski thanked Mr. Flores for keeping his business in Seabrook,
34 which is one of the few businesses that decided to stay at a time when it was eminent that the
35 highway construction was going to affect the business.

37 **1.2** Presentation of the Seabrook Economic Development Corporation Bi-Annual Report. *Paul*
38 *Dunphey, President, Seabrook Economic Development Corporation and Paul Chavez, Director*
39 *of Economic Development.*

41 Paul Chavez, Director of Economic Development presented the Bi-Annual Report as seen
42 in Attachment A.

46 Comments from City Council included:

- 47 • Are you going to hold another Economic Summit like last year? Mr. Chavez reported that
48 there will definitely be another Economic Summit; however, EDC is going to wait for
49 completion of significant milestones to bring people back to the summit.
- 50 • I'm happy to see that EDC's focus has been investing in our community and not in acting
51 like a bank.
- 52 • I would like to see the fund balances and projected revenues go down even further. It
53 would be ok to spend all of that money because that's what it is there for, and we are having
54 such success.
- 55 • Are you continuing to look at loss of business versus business gained? Mr. Chavez
56 explained that Seabrook is over the hump of loss and gain due to the highway project.
57 Business that are going to leave have left, and those that are relocating have also done so.
58 EDC is tracking new business now. EDC is still going to maintain a very conservative
59 approach, per the advice of the Finance Department, because of the highway project. The
60 EDC Board is keeping an eye out for and working with the City Manager on much bigger
61 projects that will require some of the funds.
- 62 • Is there any movement for Town Center or the Circle at all? Mr. Chavez stated that an ad
63 campaign will be pushed out soon and staff is keeping in contact with the owners in the
64 area and the owner to the north has some great news to come out soon.

65
66 Paul Dunphey, President, Seabrook Economic Development Corporation, stated that Mr.
67 Chavez did an excellent job on the presentation and stated that Mr. Chavez and his staff are
68 working hard toward pulling in businesses. Mr. Dunphey stated that Seabrook's reputation for
69 being an unfriendly city has been cleaned up and now developers come here and they think it's a
70 trap because there is too much willingness to help. A lot of companies don't use incentives and
71 Mr. Chavez has been active in finding companies that want to look at Seabrook. The focus should
72 be quality projects, which is what Mr. Chavez is searching for, and it's a difficult task with the SH
73 146 expansion. EDC has modified its grading criteria in deciding who comes to Seabrook. The
74 money is hard to spend and at the same time remain prudent about spending.

75
76 Mayor Kolupski stated that EDC has done a good job and Council appreciates it. The City
77 is moving in a positive economic development direction and there is a good fund balance. There
78 are good projects coming up that will require a lot of the current fund balance, and it is good that
79 the City and EDC was frugal in the past.

80
81 **1.2 Presentation and Oath of Office of new Seabrook Fire Marshal, Kevin Rodgers. Brad**
82 **Goudie, Director of Emergency Services**

83
84 Brad Goudie, Director of Emergency Services, stated that in the City of Seabrook the
85 health, wellness, and security is a high priority and a big part of those things is relying on the Fire
86 program.

87
88 Mayor Kolupski administered the Oath of Office to Deputy Fire Marshal, Kevin Rodgers,
89 and Mr. Goudie gave him his new badge with one work on it....Excellence.

90 **1.4** Presentation of the Post Event Report for the 2019 Christmas Boat Lane Parade that
91 took place on December 14, 2019. *Shari Sweeney, Vice President, Clear Lake Area Chamber of*
92 *Commerce*
93

94 Shari Sweeney, Vice President, Clear Lake Area Chamber, stated that she was excited to
95 be giving the Post Event Report and thanked Council for supporting the parade. Ms. Sweeney
96 explained that this year the judging was moved back to Seabrook to the Seabrook Marina, which
97 also hosted the committee activities for the parade. Ms. Sweeney noted that watching the parade
98 from Seabrook Marina allows for seeing the boats in the parade as well as the boats in the water
99 watching the parade. Finally, Ms. Sweeney stated that 40% of boater participants either live in
100 Seabrook or house their boat in Seabrook, which is double the amount of Seabrook participants
101 from last year. Folks that pay city taxes really do enjoy the parade.
102

103 Mayor Kolupski stated that it is a good time on the boat, and that is was a great event this
104 year. Ms. Sweeney reiterated that the Sunday morning awards breakfast is fun to see the boaters
105 getting awards. Also, the weather was great, perfect, this year.




